- 2.6 Both parties to obtain all internal approvals, permissions, and licences of whatsoever nature required.

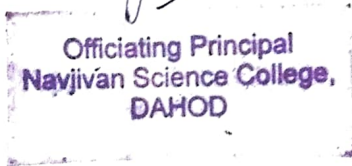
CLAUSE 3 VALIDITY
