Age Criteria

Minimum 18 years and maximum 27 years as on the closing date of the application form.

Stipend

- 1. The apprentices are eligible for monthly stipend as per Apprentices Act, during their period of engagement subject to satisfactory performance and attendance.
- 2. Poor performance or unauthorized absence may result in termination from the apprenticeship program.
- 3. The apprentices are not eligible for any TA/DA/Boarding or Lodging expenses incurred during the period of apprenticeship. The Government Engineering College, Dahod will not provide any financial assistance towards transportation.

Selection of Candidates

- Shortlisting/Screening/Selection will be based on merit according to eligibility criteria and the detailed advertisement.
- Reservation shall be applicable for SC/ST/OBC (NCL) as per Apprentices Act 1961 and Apprenticeship Rule 1992 amended from time to time.
- A merit list will be prepared based on candidates who report for document verification and are found suitable.
- Shortlisted candidates will be communicated through registered email.
- TA/DA will NOT be paid for appearing in the document verification process.
- The candidate shall be engaged in merit order on accepting tri-partite apprenticeship contract at the NATS/NAPS website and submission of a medical certificate in prescribed format along with police verification.

General Conditions

- 1. Candidates must carefully read the full advertisement before applying.
- 2. A valid mobile number & E-Mail ID is required before applying.
- 3. During apprenticeship, candidates will be governed by the Apprentices Act, 1961 (as amended).
- 4. Reservation for SC/ST, OBC, and EWS will be followed as per Government of India.
- 5. Government Engineering College, Dahod has no obligation to offer regular employment after apprenticeship.
- 6. Decision of the organization will be final regarding eligibility, selection, cancellation etc.
- 7. No correspondence will be entertained for non-selection.
- 8. Multiple applications (more than one discipline) will not be considered.
- 9. No Application Fee.
- 10. Candidates should NOT have undergone or be pursuing Apprenticeship earlier.
- 11. Candidates with one year or more job/training experience after qualification are NOT eligible.
- 12. Candidates should NOT have completed 5 years after passing the qualifying exam as on closing date. If result declaration date is missing from mark sheet, a certificate from Principal must be submitted.
